5. I recognize that as the foster parent, the health of my foster dog is the responsibility of myself and the rescue. I hereby represent that all required

vaccinations and internal/external parasite treatments for my small dog are up to date and will continue to remain so for as long as my foster dog attends Fluffy & Spikes Small Dog Daycare Inc. I will also promptly provide proof of all required vaccinations and treatments from a licensed Veterinarian to Fluffy & Spikes Small Dog Daycare Inc.

6. I understand that while my foster dog is fully vaccinated that vaccines are not 100% guaranteed and there is a small risk that my foster dog may contract a contagious disease or illness. I agree that should this occur either myself or the rescue are responsible for my foster dog's care and medical attention.

I further understand and agree that in admitting my foster dog, Fluffy & Spikes Small Dog Daycare Inc. has relied on my representation that my foster dog is in good health and has not harmed or shown aggression or threatening behavior towards any person or any other small dog. I understand Fluffy & Spikes Small Dog Daycare Inc. reserves the right to remove my foster dog from the play area and place my foster dog in a separate holding area should my foster dog display any unwanted behaviors.
