4. I hereby represent that my small dog is of good health and has not been ill with any known contagious diseases within the last thirty days.

5. I recognize that as the owner, the health of my small dog is my personal responsibility. I hereby represent that all required vaccinations and internal/external parasite treatments for my small dog are up to date and

will continue to remain so for as long as my small dog attends Fluffy & Spikes Small Dog Daycare Inc. I will also promptly provide proof of all required vaccinations and treatments from a licensed Veterinarian to Fluffy & Spikes Small Dog Daycare Inc.

6. I understand that while my small dog is fully vaccinated that vaccines are not 100% guaranteed and there is a small risk that my small dog may contract a contagious disease or illness. I agree that should this occur I am responsible for my own pet's care and medical attention.

I further understand and agree that in admitting my small dog, Fluffy & Spikes Small Dog Daycare Inc. has relied on my representation that my small dog is in good health and has not harmed or shown aggression or threatening behavior towards any person or any other small dog. I understand Fluffy & Spikes Small Dog Daycare Inc. reserves the right to remove my small dog from the play area and place my small dog in a separate holding area should my small dog display any unwanted behaviors.

8. I understand that although all dogs are fully supervised that incidents of injuries may occur from playing with the other dogs, which include but not limited to bites, scrapes, scratches, and sprains.

I further understand and agree that Fluffy & Spikes Small Dog Daycare Inc. and their caregivers will not be liable for any problems that might develop with my small dog, including, but not limited to, sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed.

It is hereby acknowledged that should I fail to pick up my small dog before Closing Time, a \$10 late fee will be charged per 15 minutes to be paid upon my arrival at Fluffy & Spikes Small Dog Daycare Inc. and before my small dog is released from Fluffy & Spikes Small Dog Daycare Inc. into my custody.

13. Fluffy & Spikes Small Dog Daycare fees are non-refundable and non-transferable, excluding the event of my small dog being dismissed from daycare.

14. I agree that my small dog may be videotaped, photographed, and/or recorded. Fluffy & Spikes Small Dog Daycare Inc. shall be the exclusive owner to the results and all proceeds of such taping, photography, and recording.

15. Fluffy & Spikes Small Dog Daycare Inc. reserves the right to permanently remove any small dog from daycare for reasons such as but not limited to illness or behavior. I understand that in extreme circumstances I may be required to pick my small dog up from daycare.
