I hereby waive and release Fluffy & Spikes Small Dog Daycare Inc., its employees, owners, representatives and agents from any and all liability which any rescue representative, foster parent or any foster dog may suffer, including specifically, but not without limitation, any injury or damage whatsoever arising from my foster dog's attendance and participation at Fluffy & Spikes Small Dog Daycare Inc.

I hereby agree to indemnify and hold harmless Fluffy & Spikes Small Dog Daycare Inc., its employees, owners, and agents from any and all claims, or claims by any member of the rescue, foster parent or any other third party accompanying me to a function of Fluffy & Spikes Small Dog Daycare Inc., or while attending the premises thereof, as a result of any action by any dog.

4. I hereby represent that all foster dogs are of good health and have not been ill with any known contagious diseases within the last thirty days.

5. I recognize that as the rescue representative, the health of all foster dogs is the rescues responsibility. I hereby represent that all required vaccinations and internal/external parasite treatments for all foster dogs are up to date and will continue to remain so for as long as the foster dog attends Fluffy & Spikes Small Dog Daycare Inc. The rescue will also promptly provide proof of all required vaccinations and treatments from a licensed Veterinarian to Fluffy & Spikes Small Dog Daycare Inc.

6. I understand that while all foster dogs are fully vaccinated that vaccines are not 100% guaranteed and there is a small risk that the foster dog may contract a contagious disease or illness. I agree that should this occur the rescue is responsible for the foster dogs care and medical attention.

7. I further understand and agree that in admitting all foster dogs, Fluffy & Spikes Small Dog Daycare Inc. has relied on my representation that all foster dogs are in good health and have not harmed or shown aggression or threatening behavior towards any person or any other small dog. I understand Fluffy & Spikes Small Dog Daycare Inc. reserves the right to remove any foster dog from the play area and place the foster dog in a separate holding area should the foster dog display any unwanted behaviors.

8. I understand that although all dogs are fully supervised that incidents of injuries may occur from playing with the other dogs, which include but not limited to bites, scrapes, scratches, and sprains.

I further understand and agree that Fluffy & Spikes Small Dog Daycare Inc. and their caregivers will not be liable for any problems that might develop with any foster dog, including, but not limited to, sickness, disease, injury, running away and death, provided that reasonable care and precautions are followed.

10. I further understand and agree that any problem that develops with any foster dog will be treated as deemed best by the caregivers of Fluffy & Spikes Small Dog Daycare Inc. at their sole discretion and that the rescue assumes full financial responsibility for any and all expenses involved.

11. I agree that any foster dog may be videotaped, photographed, and/or recorded. Fluffy & Spikes Small Dog Daycare Inc. shall be the exclusive owner to the results and all proceeds of such taping, photography, and recording.

12. Fluffy & Spikes Small Dog Daycare Inc. reserves the right to permanently remove any foster dog from daycare for reasons such as but not limited to illness or behavior. I understand that in extreme circumstances the foster parent may be required to pick the foster dog up from daycare.
